

CLEREG SCHOLARSHIP APPLICATION

The Continuing Legal Education Regulators Association (CLEreg) recognizes that one of the benefits available to its members is the opportunity to attend the annual and mid-year CLEreg meetings. CLEreg acknowledges that there may be members who cannot attend because of budgetary or financial constraints. Accordingly, CLEreg has provided for a limited number of scholarship funds that may be available to its members covering expenses related to registration fees, transportation, or lodging incurred by members attending a CLEreg annual or mid-year meeting.

Who may apply for a scholarship? A CLEreg member in good standing or a prospective CLEreg member may apply for a scholarship to attend the annual or mid-year CLEreg meeting. The applicant must be from a mandatory CLE state or jurisdiction or from a state or jurisdiction that is seriously considering becoming a mandatory state or jurisdiction.

How do I apply? A CLEreg member wishing to apply for a scholarship to cover certain expenses associated with attendance at a CLEreg annual or mid-year meeting shall complete and submit the CLEreg Scholarship Application Form no later than forty-five days prior to the first day of the meeting to which it applies.

Scholarship Decisions - The Executive Committee of CLEreg will review all timely scholarship applications. In its sole discretion, the Executive Committee may deny a scholarship application or it may grant a scholarship application in full or in part. Scholarships may be awarded on a reimbursement basis. The Executive Committee of CLEreg will notify all scholarship applicants of its decision. The decision of the Executive Committee is final.

The amount of money available for scholarship funds for each meeting will be decided by the Executive Committee. The Executive Committee shall not be required to expend all of the funds available for scholarship awards.
