

About CLEreg:

CLEreg is short for the CLE Regulators' Association. Our group has been providing education and networking opportunities for regulators in mandatory CLE jurisdictions since 1986. CLEreg also connects members via a listserv that provides invaluable day-to-day support from peers. We currently represent 43 mandatory CLE jurisdictions and welcome new and existing regulatory jurisdictions from around the world to join us. In most jurisdictions, regulatory duties include program accreditation and attorney recordkeeping duties for CLE program attendance. Transportation:

Transportation from the hotel to the resort is costly whether you rent a car, reserve the shuttle, or take a taxi. To save on expenses and environmental impact we encourage you to plan arrival times to allow sharing of transportation with other attendees.

The Hyatt Regency Tamaya is approximately 26 miles (30 minutes) from the Albuquerque Sunport International Airport (ABQ). Shuttle service is available from New Mexitours via vans or sedans that pick up every hour on the hour between 6 am and 6 pm, with after hours pick-up on request. Reservations are required (call 505/771-3739) at least 23 hours before arrival or departure from the hotel. Cost is \$40 one way for the first person and \$10 for each additional person within the same party. Taxi and limousine service can be booked through the hotel guest services at (505)867-1234. Taxi fares from the airport to the Hyatt Tamaya are approximately \$90 one-way.

If you rent a car, complementary self-parking is available at the hotel.

Driving Directions to Tamaya Resort, Santa Ana Pueblo, NM

From the Albuquerque Airport (Approximately 26 miles) and South from I-25:

Exit to the right as you leave Sunport Blvd. Stay towards the right as the on-ramp to I-25 North will be on your right. Enter and follow I-25 North towards Santa Fe to Exit #242. Turn left on to Hwy 550(44) West toward Bernalillo. Proceed 2.4 miles to the intersection of Tamaya Blvd. and Hwy 550 just past the Santa Ana Star Casino. Turn right at Tamaya Blvd. and proceed 1.2 miles to the 3-way stop (Tuyuna Trail). Turn right and proceed 1.3 miles to the Resort. Proceed to the front entrance courtyard.

Approximate driving time: 30 minutes

From the Santa Fe Airport: (Approximately 42 miles)

Travel East on Airport Blvd. to Cerrillos Road. Turn right on Cerrillos Road and follow to the entrance of I-25. Take I-25 South toward Albuquerque to Exit #242. Turn right on to Hwy 550(44) West toward Bernalillo. Proceed 2.4 miles to the intersection of Tamaya Blvd. and Hwy 550 just past the Santa Ana Star Casino. Turn right at Tamaya Blvd. and proceed 1.2 miles to the 3-way stop (Tuyuna Trail). Turn right and proceed 1.3 miles to the Resort. Proceed to the front entrance courtyard.

Approximate driving time: 40 minutes
